

Digital Innovation Cluster Challenge

Application Form for Digital Service Providers (DSPs)

Introduction

The Belize Trade and Investment Development Service (BELTRAIDE) is seeking proposals from Belizean-based and registered Digital Service Providers (DSPs)¹ to form a cluster and develop a project focused on addressing the critical skills and human capital gap within the sector. This initiative aims to build a strong human capital foundation for DSPs, ultimately enhancing their competitiveness and ability to serve Belizean Micro, Small, and Medium Enterprises (MSMEs). BELTRAIDE is offering non-reimbursable technical assistance grants to support projects focused on skills and human capital development. Proposals can request up to a maximum of BZ\$100,000. However, the grant will cover a maximum of 80% of the total project budget. Therefore, the proponent entities contribute to at least 20% of the total project budget. This contribution can be either financial or in-kind.

Eligibility (see guidelines for additional detail)

- The cluster must consist of at least three entities with a minimum of two (2) Belizean-based and registered DSPs.
- The lead entity must be a formally registered, Belizean DSP.
- Non-profit entities such as academia, business support organizations, industry associations, and government institutions are encouraged to participate within the cluster project proposal.
- Do note that the supplier of the technical assistance can not form part of the cluster as the proposal will be required to include at least three suppliers per technical assistance activity being proposed. The proposed supplier(s) will be selected in accordance with the IDB's Procurement policy.
- The cluster of DSP firms must demonstrate a commitment to contributing counterpart resources (financial and/or in-kind) to implement the project. (BELTRAIDE grant funding can cover a significant portion, up to 80% of your project budget, with a maximum limit of BZ\$100,000).
- Firms that have recently received grants from BELTRAIDE within the last 12 months are ineligible to apply.

¹ DSPs are companies that provide digital and online services to their clients including cloud services, hosting, software development, data analytics, digital and social media marketing, e-commerce solutions, mobile app development and more. DSPs play a critical role in closing digital divides and fostering the uptake and adoption of digital practices amongst businesses throughout all economic sectors in local economies.



• Firms that are currently executing a consultancy or participating in a procurement process for an IDB-financed project will not be able to participate as a Lead firm but can be included as an entity under the cluster.
